


MILLIMAN'S SUBDIVISION

SURVEYOR'S CERTIFICATE

I, Robert E. Sayers, Surveyor, certify that I have surveyed, divided and mapped the land shown on this plat, described as follows: MILLIMAN'S SUBDIVISION, a Subdivision situated in the SE 1/4 of Section 27, Town 7 South, Range 12 West, Constantine Township, St. Joseph County, Michigan is described as follows: Commencing at the Southeast Corner of said Section 27 and running thence N 00° 06' 23" W along the east line of said section 27 for 571.00 feet to the Point of Beginning of this description; the boundary runs thence N 00° 06' 23" W 709.45 feet, thence S 56° 02' 20" W 1361.54 feet, thence S 18° 14' 40" E 246.80 feet, thence N 74° 44' E 1069.30 feet to the Point of Beginning of this description.

This description contains 10 numbered lots; that I have made such survey, land-division and plat by the direction of the owners of such land; that such plat is a correct representation of all of the exterior boundaries of the land surveyed and the subdivision of it; that the required monuments and lot markers have been located in the ground as required by Section 125 of the Act; that the accuracy of the survey is within the limits required by Section 126 of the Act; that the bearings shown on the plat are expressed as required by Section 126 (3) of the Act and as explained in the legend.


